## **Sanitary Check Valves**


#### **Description**

Parker Sanitary Check Valves are utilized within processing systems to to avoid product return. The disk opens when the pressure under the disc is greater than that existing in the upper part of the valve. The valve closes when the pressures are balanced. A greater counter pressure will allow the valve to close.

These valves are made from high-grade 316L heat traceable stainless steel. When properly installed, these valves are fully drainable and meet 3A standards. Valves can be easily dissembled and re-assembled for cleaning or maintenance.

Standard configuration is sanitary clamp with EPDM seal and 32 RA sanitary polish. Weld and threaded versions are available upon special request.






